CEO REMARKS



In 2018, our three organizations began implementation of our new strategic plan focusing on three major areas: **(1) revenue/growth**, **(2) engagement**, and **(3) strategic partnerships**. The plan also includes the following five strategies: (1) develop and implement an enterprise-wide marketing and communication program; (2) develop and make available best-in-class palliative care resources; (3) solidify and strengthen relationships with organizations that can extend the reach of the organization; (4) implement technology improvements and advances to position the organization for long-term growth and success; and (5) expand and refine the employer program to drive continued growth (see graphic on back page). Each organization developed a work plan with tactics identified to help us be successful in meeting our goals.

As an enterprise, we also work on joint initiatives that impact all three organizations, including enhancing our brand, image, marketing and communications; developing our IT infrastructure; and increasing the voice of palliative nursing at the national level. A few of our major initiatives this year included the implementation of two Palliative Nursing Summit Project Teams: the Pain Project Team and the Advance Care Planning Project Team. The Pain team developed the first webinar in a series related to pain assessment and management, attracting nearly 1,000 registrants. The Advance Care Planning team launched the #ISaidWhatIWant social media campaign to great success as well. Nurses from 20 nursing organizations who participated in Palliative Nursing Summit joined us to work on these initiative, and 20 additional organizations heard of our work and decided to join us, for a total of 40 participating organizations. We also finalized the implementation of our major IT initiatives in 2018, including a new membership database, learning management system, and certification platform.

Beyond our enterprise-wide successes, HPCC developed their Value Propositions, one for individual nurses and one for employers, which will both be released at the HPCC Certification Recognition Luncheon in March 2019. Additionally, HPNF had another successful year in fundraising and in supporting programs of HPNA and HPCC.

In late 2018, I announced my retirement as CEO of our three organizations, effective March 31, 2019. I am very proud of the work that the Boards, staff, volunteers, and I have been able to accomplish over the last seven years. The organizations are strong and well-poised to continue to expand and develop to achieve our vision to transform the care and culture of serious illness.

The **Hospice and Palliative Nurses Association** (HPNA) serves hospice and palliative nurses through member engagement, networking opportunities, and educational products and services.

The **Hospice and Palliative Credentialing Center** (HPCC) enables hospice and palliative nurses and other Nursing members of the interdisciplinary team to demonstrate expertise in their practice, affirming their palliative nursing knowledge and skills.



The **Hospice and Palliative Nurses Foundation** (HPNF) supports the major initiatives of HPNA and HPCC through numerous scholarships, grants, and award opportunities.



ENTERPRISE INITIATIVES

Palliative Nursing Summit: Project Teams

Two project teams that grew from the 2017 Palliative Nursing Summit began meeting in March. The Pain Project Team, chaired by Polly Mazanec, held a webinar on pain management hosted by HPNA in

May that drew nearly 1,000 registrants. That team meets quarterly and has formed four work groups concentrating on clinical practice, education, regulatory/advocacy, and research. The Advance Care Planning (ACP) Project Team, led by Joanne Reifsnnyder and Todd Hultman, created materials to promote ACP for the 2018 Annual Assembly and started the #ISaidWhatIWant social media campaign, which began in the fall. Participants of the social media campaign included 14 organizations that took part in the Palliative Nursing Summit and 33 new organizations, for a total of 47.

Employer Partner Program

The Employer Partner Program continues to support nursing teams with professional development and educational opportunities at an affordable price. Organizations that have palliative care programs, hospice facilities, and home health programs, including an increasing number of large national employers and smaller regional agencies, are benefiting from volume purchases of memberships and educational resources, certification exams, and job postings. In 2018, the Employer Partner Program grew by more than 50% with similar expectations for 2019.

Palliative Nursing Leadership Development Program

In 2017, a task force led by Abraham Brody began planning to develop a program designed to provide leadership development experiences and mentoring to nurses. In May, HPNF was awarded a \$265,375 grant from the Cambia Health Foundation to develop and support a pilot program over 18 months. Criteria and content for the first cohort were created in August, and recruitment for participants took place in the fall. There were 58 applications collected for the 15 slots in the cohort. Selected cohort participants will attend a full-day preconference at the 2019 Annual Assembly.

New Database, Website, and Education Platform

It was a year of technological change for the enterprise. In May, a new member database provider and website were introduced, and in October, HPNA debuted a new education portal and learning management system called HPNA University. These changes have been met with positive responses from members, certificants, and donors.

Pediatric Palliative Care Task Force

An enterprise-wide task force created in 2018 looked at and evaluated pediatric palliative care offerings through each organization. The group's work yielded a series of recommendations that will enhance services for pediatric palliative nurses.

ENTERPRISE SOCIAL MEDIA

Our enterprise social media engagement saw significant growth in 2018. In addition to Facebook and Twitter, the three organizations also share YouTube (**HPNAInformation**) and LinkedIn accounts (**Hospice and Palliative Nurses Association**), which combined have nearly 1,600 subscribers and followers.



#ISaidWhatIWant Social Media Campaign

Beginning in October 2018, over 20 organizations associated with the Palliative Nursing Summit ACP Team posted messages on social media about ACP using the **#ISaidWhatIWant** hashtag to encourage nurses in all specialties to lead by example and establish their own advance directives. The initial campaign ran until January 2019, with internal HPNA social media reaching **45,860 people on Facebook** and **43,061 on Twitter**. The hashtag was retweeted over **200 times**, reaching nearly **140,000 people**. In the future, the team plans to include this hashtag in messaging and seek funding to increase the size and scope of the campaign.

HPNA ANNUAL EVENTS

Annual Assembly

Sponsored by AAHPM and HPNA, the Annual Assembly of Hospice and Palliative Care was held in Boston, MA, March 13-17. The conference drew over 3,000 attendees, despite a blizzard striking the northeast days before the event.

Clinical Practice Forum

The HPNA Clinical Practice Forum celebrated its 12th year with the theme *Continuing the Path: Advancing Expert Care in Hospice and Palliative Nursing*. The event took place at the Marriott City Center in Pittsburgh, PA, September 27-29. Keynote speaker Nadine Barrett, PhD, MA, MS, from Duke University, presented *Health Disparities, Diversity, and Inclusion: Where Do We Go from Here*.

ELNEC

In 2018, HPNA hosted three End-of-Life Nursing Education Consortium (ELNEC) Train-the-Trainer courses, with both a pediatric palliative care and a core course in New Orleans, LA, in April, and a core course in Orlando, FL, in October. A full-day post-conference course, *Principles of Palliative Care Across the Care Continuum: The Nurses Role*, was also held in April. Nearly 150 people attended the courses and post-conference.

Leadership Weekend

Our annual Leadership Weekend took place July 20-22 in Pittsburgh with over 100 attendees. Representatives from the enterprise organized and attended the three-day event, which featured presentations like *Social Media for Today's Nurse Leader*, *LGBTQ Principles and Practice in Hospice and Palliative Care*, a minority/diversity interactive activity with the boards, and an update on the Leadership Development Module, due in 2019. For the fourth year in a row, HPNA, HPCC, and HPNF held a joint board meeting to discuss enterprise-wide topics and concerns.

Virtual Conference

Partnering with the National Hospice and Palliative Care Organization and AAHPM, HPNA held the annual Virtual Conference July 18-19. The conference, *Turning Points: Mastering Transitions in Care*, drew nearly 400 attendees.


HPNA UPDATES

The American Nurses Credentialing Center's Commission on Accreditation acknowledged our commitment to lifelong learning and commended HPNA in achieving reaccreditation as a provider of continuing nursing education (CNE) valid through March 31, 2023. Our organization provided **over 500 hours of instruction for CNE** and **200 Category 1 Designated Pharmacological credits** to nearly **2,000 RN and APRN learners** in 2018.



Technology Updates

The HPNA Education Department was able to update its course catalog by switching to a new learning management system, making its courses easier to access through the new **HPNA University portal**. All previous valid content was updated and placed in the portal, and both RN and APRN monthly webinars were created for members. These webinars will be available online with CNE credits. Work also continues on the Clinical Orientation Program, which will debut in early 2019, and the RN Pathways project.






Celebrating 25 Years

This year marked the 25th anniversary for HPCC, founded as the National Board for Certification of Hospice and Palliative Nurses in 1993. Since its inception, nearly 53,000 individuals have achieved certification through the organization. To celebrate the anniversary, reactivation fees were reduced to \$25 for the year and certification pins for all seven credentials were discounted to current certificants.

Examination/Exercise Development Committees Updates

The Examination Development Committees continue to write and approve items for future exams, establish test forms, review exam results and test-taker comments, and perform an annual review of the respective candidate handbooks.

Updated HPAR Process

In addition to retaining the CHPCA and CHPLN credential through Hospice and Palliative Accrual for Recertification (HPAR), the HPCC board updated the process to offer more opportunity and flexibility to obtain points and recertify. These updates, and the use of the online recertification platform for ACHPNs and CHPNs, continue to streamline the process of HPAR submissions.

Credential Update

As of January 1, 2018, the CHPCA and CHPLN exam are no longer be offered. However, those who previously earned either credential will be able to retain the credential through the HPAR process.


Value Propositions


